



Moving into the seasons of winter and basketball

hen this column comes out; the first semester of the school year will have just come to an end and staff and students will be on Christmas break. I am not sure where the time went, but at least for me, this past fall went by unbelievably fast! School will resume on Wednesday, January 5.

Earlier this past month, Governor Kristi Noem gave her annual budget address. As it pertains to education, she is recommending the allocation of funding to increase by 6 percent to help schools increase and improve teacher pay in the state; as well as improving the wages of classified staff within districts as well. The allocation



of these funds will be for the general fund, which is primarily utilized for salaries and benefits of employees. We will see if the legislature follows through on the recommendation, but until the final gavel falls, we will have to wait and see how it plays out in Pierre this upcoming legislative session.

Boys and girls basketball seasons have begun across the state. The girls began on Monday,

November 22, and the boys on Monday, November 29. Brock Pashen and Alex Sumption are coaching the boys, while myself, Sarah Sumption, and Holly Lapka are coaching the girls. A total of 22 boys are participating, with 10 from Frederick and 12 from Leola. A total of 15 girls are participating, with 11 from Frederick and four from Leola. The girls have played five games and are currently 1-4, while the boys have played four games and are 0-4.

The Frederick Area athletes in grades nine through twelve who participated in football, volleyball, and cross country this past fall have all qualified their respective activities for the Academic Achievement Team Award. To qualify, the collective average of grade-point averages by all student-athletes involved in the varsity sport must be at or above a 3.0. The football team, volleyball team, and both boys' and girls' cross-country teams were all well above that mark, with the lowest average being 3.83. Our studentathletes are doing extremely well academically!

We have had a little taste of winter this past month, and undoubtedly there will be more to come before it is all said and done. We look forward to resuming school and the activities that come with it, and here's to hoping for a wonderful spring semester!




The 2021-22 junior high girls team had a roster of 15 players in grades 6-8.
