

## **Opt-out goes before voters April 9**

In an upcoming vote on April 9, 2024, residents of the Frederick Area School District will have the opportunity to voice their opinions on a proposed \$450,000 opt-out. This vote holds significance because of various factors related to previous budget allocations and future planning needs of the district.

Previously, the Frederick Area School District passed a \$200,000 opt-out, which is set to expire this year. The new proposed opt-out includes an amount of \$450,000 for a period of five years. Looking ahead, there are uncertainties regarding the upcoming teacher accountability review and the changes this may bring to teacher compensation packages, which will in turn affect all employee expenses and general fund as a whole. With teacher shortages still being a concern statewide, compensation packages will need to remain competitive to find quality teachers in coming years.

Changes to the capital outlay funding formula are also part of the reason for the higher proposed opt-out amount. The capital outlay fund is established by

#### What does "opt-out" mean?

Here's the explanation from the South Dakota Department of Revenue:

"Opting out is to impose an excess levy above any current limitations. If the school district cannot operate on the revenues generated by the maximum allowed for the general or capital outlay funds, then the school district may choose to "opt-out" of the limitations.

## A reminder about winter weather attire and policies

Well, after a warmer extend-ed fall, it appears that the cold temperatures have arrived in our area. Although after the winter we had last year, I don't think anyone is too upset about the delay. That being said, it is a good time to check your cars for your winter emergency gear and make sure your kids are dressed appropriately for school and recess. As a mom of a teenager myself, I often must have the conversation with my son that shorts are not for winter wear in South Dakota, even if you do only have to walk across the parking lot. You never know what could happen-flat tire, deer crossing your path, or a sudden patch of black ice that could cause you to be out of your vehicle for a while. We do



our best to keep the buses warm, but those of you who rode the school bus know well how cold they can be, a minimum of pants and coats (with gloves and hat packed) would be the preferred bus dress code this time of year.

For those of you with elementary-age students, we do go out to recess daily if the air temperature is above 0°F. We do factor in the "feels like" temperature when wind chills are a concern and will make a judgement call

on if it is safe to go outside or not. It is best to always assume that we will be going out to recess and send students with snowpants, boots, winter coats, hats, and warm gloves.

If you have trouble getting appropriate winter gear for your child, contact the school. The SADD group is currently hosting a winter gear drive for students and the surrounding community. If you are cleaning out closets and have some you no longer need, feel free to drop them in the bin in the entryway at school.

Parents, just a reminder on snow day notifications. We have been lucky up to the time of this writing that we have not had a snow day yet this year. Snow day and late start notifications will be made through the all-call system (both phone and text if you signed up for the text feature),

our Facebook page, on Hub City Radio, and Dakota News Now. Most of the time, we consider a snow day just a snow day, but in circumstances where we have at least a day's notice that a big storm is coming and it is likely that we will have to close, we may call it a distance learning day.

The schedule for distance learning class times can be found on our website, and students will know before leaving the building what is expected. We try our very best to avoid waking up in the morning and announcing a distance learning day; we don't like to catch anyone off-guard if we can avoid it.

With that, I hope we can have a short winter with some above average temperatures. The more we prepare, the better it will be right?

### **Co-managers handle different parts of Elevator's business**

Frederick Farmers Elevator Coop is a well-established asset to the Frederick area. It has served many local farmers over the years and continues to do so.

In 1998, a group of local farmers invested in the purchase of the current facility from Wheat Growers Inc. They continue to offer many services such as grain handling, buying, and selling, and offering feed supplies. They sold shares in the business and added condo storage for sale to the farmers. Since the initial purchase, they added additional grain bins and updated the existing storage space. As of now they have a storage capacity of 2.14 million bushels.

The current co-managers are John Enge and Kristina Sigaty. The elevator employs a staff of six full-time employees and one part-time employee, and additional seasonal help is hired during harvest time. John manages the general operations, and Kris-

tina manages the grain marketing and grain origination.

In the future, to better serve the farmers, they are looking to add more options for the grain division with OTC (over the counter) grain marketing programs and expanding storage. They are very proud that this business is kept local and can offer competitive pricing for the farmers. They offer direct shipping to the AGP soybean processing plant in Aberdeen and sell grain to Glacial Lakes in Aberdeen and Mina and to Wheaton Dumont in Britton. On the feed side, they offer a wide variety of feed products for all kinds of livestock, and creep feed delivery.

law to finance the acquisition, lease, or addition of real property, equipment, or software for instructional purposes. For example, this fund can be used for purchasing textbooks, renewing instructional software, equipment, facility construction, grounds, and renovations. Changes to the capital outlay formula will make it impossible for our district to transfer the amount of money we typically would to cover these expenses. Previously, the district could carry over the same amount from the previous year, which was \$366,125. Unfortunately, this is no longer possible. As per SDCL 13-16-6, the district can transfer a maximum of 45% of the total tax revenue for the current fiscal year. Based on estimates for the next tax year, it is anticipated that \$263,160 can be transferred, which is \$102,965 less than the previous year.

The Frederick Area School Board reviews the budget every year. Outside of the first year, the board has not taken the full \$200,000 amount of the opt-out previously passed. The second year, \$100,000 was utilized and then in this final year, \$170,000. Also, in the past, the school district had a requirement to utilize the entirety of a \$200,000 fund in the first year of opting out. However, this stipulation is no longer in place, allowing for more flexibility in budget management. It is the intention of the board to continue its review of the budget each year and the practice of only taking what is necessary of the \$450,000 opt-out.

The FASD school board believes that transparency is important and is going straight to the vote of the people on this proposed opt-out. This vote holds significant implications for the future of our school district, and it is crucial for all stakeholders to stay informed and participate in the decisionmaking process.







# At 17-1, Titans have high postseason hopes

Hard work every game and a deep bench have combined to give the Titans boys basketball team a 17-1 record, putting them solidly at the top of the Region 1 rankings and near the top of the list of Class B teams in the state — #4 as of this writing.

The Titans have won against strong Class A teams, including Aberdeen Roncalli and Platte-Geddes, as well as teams that stymied them last year, such as Ellendale and Warner. Their lone loss came in a close showdown with Faulkton on Jan. 25. With two games remaining in the regular season, the Titans hope to enter the postseason in a strong position to make it to the SoDak 16 and from there fight for their spot in the state tournament.

The season is exceeding Coach Brock Pashen's expectations.

"You can't expect to go 17-1 with the quality of a schedule that we have," he said. "The boys have competed every practice, caught on to what we are trying to do, and are applying it in games. Our one loss we didn't play well and didn't do the things we had been doing in our wins, and we paid for it."

The Titans' success has been a team effort.

"Brayden Sumption and Noah Kippley are leading us in scoring, but it is the 3-8 points we get from Gavin, Milo, Ethan, Westyn, Titus, Taylor, and Winston that can demoralize and put teams away. We have a lot of unselfish kids who play well together, support each other, and play well in their role."

Team members have adapted to the team's new style and tempo, which can be described as fast and relentless. They are able to keep up that speed because of the number of players who can keep up defense at that level, allowing substitutions when necessary without allowing any slack on the court. "They have bought in to the constant pressure and harassment that we are able to put on teams," Pashen said.

They are also showing they can adjust and dig even deeper when necessary. Finding a way to win against Warner after not playing well for three quarters showed some maturity in the team, he said. "We forced some mistakes and started the fourth quarter on a 13-0 run and closed the game with defense, rebounding and some good possessions offensively."

The games remaining in the season will require their full effort. Herreid-Selby is traditionally solid, though they have a losing record this year, and Ipswich has been winning against tough competition. "There are no gimmies in February which should have us tested for the playoffs," Pashen said.

"Right now we are sitting #1 in the Region and still feeling like we can do things a lot better. We need to do things right each game, find a way to win, and move on."


