

### Six Titans run at state XC meet

Titus Kippley's 15th-place finish adds to Frederick Area's haul of hardware for the season

Frederick Area's cross country team showed its strength in the last three meets of the season.

The successful series started with the Lake Region Conference meet on Oct. 8 in Ipswich, where junior runner Titus Kippley won the boys varsity race and led the Frederick team to a repeat LRC victory. Sophomore Howard Sumption's third-place finish was key bringing home the championship, as was freshman Tate Dosch's 10th-place run.

The team's success continued at the Region 1B meet on Oct. 15 in Webster, where four individual runners qualified for the state meet by placing in the top 20: Titus Kippley (5th), Howard Sumption (9th), Tate Dosch (17th) and eighth-grader Hadleigh Hoggarth (18th). The boys team placed second, which meant




## **Corner:** Juniors will take the ACT as a dual-purpose test

provide a schoolwide culture of caring and support while having a little fun too. In future *F.Y.I.* editions, instead of the student of the month pictures you are used to seeing, you may find a few pictures of student families in action.

Another change I would like to note is with our state testing this spring. In the past, all students in grades 3-8 and 11 have been required to take the South Dakota English Language Art, Math, and some Science assessments. This will remain the same for students in grades 3-8, but starting this spring, our 11thgrade students will take the ACT in place of the South Dakota assessments. The ACT is typically taken by college-bound students as part of their acceptance criteria. The test has always come

with a fee at the student's expense. Now, our juniors will be given the ACT at the school, one time, free of charge during our state testing window. Their test scores will count toward the school's accountability and report card while also providing the student with an opportunity to submit the scores to colleges for acceptance. It is required for all 11th-grade students to take this proctored ACT just as they did other state assessments in the past. Students may elect to take additional tests outside of the state's testing window, but any additional tests are at the student's expense. This is a great opportunity for our students to demonstrate their skills while saving some money in their application process. This year, keep your 11th grade student calendars open for March 25, 2026, as the date for our ACT.





# Titans finish season short of playoffs

This was the second and final year of our realignment cycle, and our schedule was the same as last year's. We opened the season with our three non-conference games, including Redfield, Britton-Hecla, and Stanley County. We defeated Redfield in the opener 54-22, but lost Ethan Petrich to a torn ACL on the game's first offensive play from scrimmage. Milo Sumption was already out with an ACL from last basketball season, and the injury bug bit us frequently off and on all season with a variety of ailments. We hosted Britton-Hecla for our homecoming game in Frederick and lost 36-6. We then traveled to Fort Pierre to play Stanley County. We scored a late touchdown with less than three minutes to play to take a 30-28 lead, but couldn't hold on, giving up a touchdown with seconds left in the contest, losing 36-30. We opened our conference season with Leola's homecoming, defeating North Central 44-14. Next up was a date at Faulkton Area, but their field was too wet to play on, so the game was moved to Warner's stadium. We dropped that contest 37-0 and then traveled to Mellette to face Northwestern in our last road game of the season, coming out on top 38-8. Our last two opponents were Ipswich and Warner, two highly ranked teams all season in Class 9A. We lost our contest to Ipswich in Leola 32-6 and did the same with Warner in Frederick in our season finale 33-6. We finished the season with a 3-5 record and fell short of qualifying for the playoffs.

Statistically speaking, on the offensive side of the ball, we averaged 5.65 yards per carry (6.15 last year), 14.74 yards per reception (15.49 last year), and we completed just 28% of our pass attempts (60% last year). We scored
