Community Store conversation continues

Store board to provide an update, get more feedback on Feb. 2

Members of the community are invited to a second public meeting at 7 p.m. Monday, Feb. 2, at the Community Center to hear an update on the Community Store's current situation and discuss possible paths forward.

Store board member Thersia Cox said the situation is better than it was on Dec. 22 when the previous public meeting was held.

"Our sales have gone up," she said. "We appreciate the support that we've gotten from the community."

The board has been working to address the store's financial situation by sourcing from lower-cost vendors and keeping staffing to a minimum. Cox recognized efforts by many people to keep the store running: board members, community member Stacy Bretsch, and employees Daisy Christiansen, Dusty Johnson, Tami Thom-

as, and Olivia Morlock.

"We wouldn't have gotten this far without them," Cox said. "I am proud of what we've done in the last five weeks."

Movement is in the right direction, but the store still has some big problems to solve. The challenges it faces were discussed at the Dec. 22 meeting, when about 40 community members gathered to discuss the store's future. At that point, the situation was dire: The store was financially overextended, its manager had resigned, and many shelves were bare. Board president Miles Bretsch summarized the basic issue as an expenses-to-income

problem: "We can't afford the salaries we've got for the sales we've got. It just don't work."

Board member Wyatt Sumperton started the public conversation by asking for input. "What we want to do tonight is open it up to everyone here, whoever wants to speak, for ideas, concerns, maybe some solutions—any little thing that might help keep the store going, or ultimately let us know that maybe the community doesn't want the store anymore."

Community members there seemed unanimous in their support of the store. They

Parents, remind kids to dress for the weather

As I write this article for the FYI, the temperature is -5 degrees and is getting colder as the day goes on. I am always amazed at the number of teens that come to school in shorts and sweatshirts, no coats with these kinds of temperatures. Even going up to the bus for lunch many students tend to either leave warm gear in their car or just "risk it." We do our best to ask them to put on coats, but a reminder from home about the importance of dressing appropriately during these cold temperatures and seeing that they have the appropriate gear is helpful too.

When it comes to riding the bus, we do our best to keep the buses warm, but sometimes things happen that delay our travel or cause a bus to stop. A minimum of pants and coats (with gloves and hat packed) would be the preferred bus dress code this time of year.

For those of you with elementary age students, we do go out to recess daily if the air temperature is above 0°F. We do factor in the "feels like" temperature when wind chills are a concern and will make a judgement call on if it is safe to go outside or not. It is best to always assume that we will be going out to recess and send students with snowpants, boots,

winter coats, hats, and warm gloves. If you have trouble getting appropriate winter gear for your child, contact the school.

In other news, the school district is actively reviewing English Language Arts/Reading curriculum for grades K-12 to select updated curriculum in this area starting next school year. Development Corporation plans for 2026

The Frederick Development Corporation (FDC) held its annual meeting Jan. 28 to review its work over the past year and discuss potential areas of focus for 2026. Board members reviewed the organization's 2025 annual report, which showed a focus on housing, including managing its properties, the sale of a completed twin home, and planning for future housing development.

One topic raised during the meeting as the FDC makes plans for the new year was the possibility of developing a convenience store with truck parking near the existing gas pumps along Highway 281. The board is discussing the idea after being approached by Agtegra, which currently operates the gas pumps under a long-term lease with the FDC. Under the potential structure discussed,

the FDC would own the building, and Agtegra would lease the facility and operate the store, similar to the arrangement currently in place for the gas pumps.

Board members noted that one reason they are considering the project is because it would capture new revenue from highway traffic, particularly vehicles that do not currently stop in Frederick. One board member noted that a recent traffic study showed that the number of vehicles passing by has nearly doubled in recent years, to 2,500-3,000 vehicles a day.

Board members emphasized that the idea is in a planning stage and that no final decision has been made. Any potential project would require further evaluation, including financial analysis and consideration of community input, before moving forward.

In addition to the convenience

store discussion, the board reiterated its ongoing interest in housing-related work, including exploring options for funding a spec home project on a lot on Second Avenue. The FDC's recently completed housing study suggested that rental housing is a potential need for the community, so that will be on the FDC's radar as well.

Many items donated to Historical Society in 2025

Our facility was used to host gatherings for two different graduating classes for former Frederick High School graduates. The class of 1964 met during mid summer and the class of 1985 met during the latter part of the summer. The participants were pleased to have a place to meet and share memories from days gone by.

One of our priorities is to maintain the buildings and the property for public use. We take pride, along with your support, to be able to provide a meeting place for various events.

Our main project this year was to give the Senn Schoolhouse a good scraping and a couple of coats of paint. Nothing like a fresh coat of paint to give the building a sparkle. We also had the wood trim around the bay windows and door on the west side of the Fylppa Building touched up. Thanks to Zach Mikkonen (Class of 2019) for helping with these projects. We would also like to thank the North Brown Community Foundation for helping fund these projects with a grant sponsored by the foundation. Also thanks to Gappa Electric for their help and support with our projects.

We also had the opportunity to add some memorabilia to our museum for future generations to enjoy. The family of a former Frederick resident and area Lutheran Pastor, Reverend

Thorson, had many of his items used by him during his ministry during the 1950s. There were a number of things that were unique to the Lutheran pastors such as his robe, collar, various literary publications, and a vintage typewriter which was in excellent condition.

Another family donated a beautiful Finnish bible used by a Finnish pastor who served the Finnish community during the 1800s. And finally the Frederick Lutheran church donated an organ which was used in the Lutheran church for more than 70 years.

Former FHS graduate Dave Campbell (Class of 1985), a collector of military memorabilia, donated a footlocker loaded with equipment from WWI. The footlocker belonged to an area soldier. Military clothing, caps, a helmet, ammo belt, goggles, instruction manuals, shovel for digging foxholes and other military items made up the contents in the footlocker. The owner of the footlocker, Private Senn, was also related to the Senn family who owned land north of Frederick. The one-room Senn Schoolhouse located on our property, was moved from the Senn farmstead a few years ago.

As the FAHS enters our 16th year of operations, we are so thankful for the support and contributions we receive from our members and donors to keep our mission alive.

Also a special thanks to all the volunteers who donate their time and energy "to celebrate our heritage and preserve it for future generations."

Frederick Area School District No. 6-2

Notice is hereby given that the Frederick Area School District No. 6-2, Frederick, South Dakota, has been audited by Cahill Bauer & Associates, LLC for the year ended June 30, 2025. A detailed report thereon is available for public inspection, during normal business hours, at the business office of the School District, and also available at the Department of Legislative Audit in Pierre, South Dakota or on the Department of Legislative Audit website at http://www.state.sd.us/legislativeaudit/Reports/reports_all.htm.

The following findings and recommendations provide a brief description of material weaknesses in internal control that are described in more detail in the audit report.

Finding: A lack of segregation of duties over revenues and expenditures exists, which could result in errors not being found in a timely manner.

Recommendation: We recommend a high level of awareness be maintained by management to assist in preventing, detecting, or correcting matters that may arise due to this internal control weakness. Compensating controls should be implemented as necessary.

Finding: We proposed material audit adjustments that would not have been identified as a result of the School District's existing internal controls, and therefore could have resulted in a material misstatement of the School District's financial statements.

Recommendation: It is the responsibility of management and those charged with governance to make the decision whether to accept the degree of risk associated with this condition because of cost and other considerations.

Finding: The School District does not have an internal control system designed to provide for the preparation of the annual financial statements being audited, including required footnotes and disclosures, in accordance with generally accepted accounting principles. As auditors, we were requested to draft the financial statements.

Recommendation: It is the responsibility of management and those charged with governance to make the decision whether to accept the degree of risk associated with this condition because of cost or other considerations.

Finding: The School District is required to properly calculate payroll deductions based on the appropriate compensation as defined by law.

Recommendation: The School District should implement a review process for payroll that can identify errors and/or miscalculations in payroll.

recognized it as a place tied to local history and pride, as well as a local gathering place—one of the few places regularly open during the day. “Every person in here tonight wants the store to stay open,” said Frederick resident Gary Peterson. “So, what we need to do is figure out how we can make that happen.”

But the challenges, many of them out of the hands of the community, aren’t easily overcome. Some of the problems have been with the store for years, including more choice at stores elsewhere and produce spoiling before it sells. Other challenges are new, such as not being able to prepare food on-site because none of the remaining workers have the needed food safety training.

One significant new challenge is the availability of grocery delivery in Frederick. “We’re up against the Walmarts, the Sams Clubs that deliver right to your door,” Cox said at the meeting. “It’s a whole different kind of situation than it was 20 years ago ... People can sit on their couch

and order everything they need.”

There seemed to be general agreement that a new direction for the store was needed. The conversation focused on practical changes that could make the store more viable while preserving its role as a hub of the community. A variety of options were discussed:

- using different vendors with better terms, products, and/or prices
- setting up a pre-ordering system or online ordering with pick-up at the store
- reducing inventory to focus on predictable need
- limiting hours
- focusing on ready-made meals or take-and-heat options
- continuing to use the building as a community gathering space in other ways

The plan at the end of the December meeting was for store board members to meet to discuss these ideas, then bring a plan to the community. Monday’s meeting is the date for community members to get that update.

Titans finding their rhythm as a team

The Titans are sporting an 11–2 record as they prepare for their last matchup of January against South Border. Head coach Brock Pashen said the team has learned how to handle close games without losing focus on what matters most.

“We’ve found ways to win games that I’d consider coin flips,” Pashen said. “Win or lose, we’d still have the same boys in the locker room, so we’re just focusing on the things we can control and on getting better where we need to.”

That approach has led to a balanced offensive effort, with different players stepping up from game to game. The team’s leading scorer has rarely been the same player in consecutive games, reflecting a lineup in which scoring responsibilities are shared.

And on defense, everybody is expected to work. Pashen pointed to the team’s performance following the Britton game as a turning point.

“I think the boys have seen what happens when we focus on the dirty things—defense and rebounding,” he said. “They’ve really bought into accepting their role and being a star in that role. They’ve put their egos aside for the good of the team and are doing what’s being asked of them.”

The team has found its way to the top 10 in Class B seed points, which, if they can stay there, would give them a solid footing from which to compete in the postseason.
